Re: Muskego Warriors Youth Baseball  
2nd Annual Invitational Tournament  
June 23-25, 2006

I attach the invite for our tournament to be held again in Muskego this coming summer. We look forward to building on what we started last year. In fact, we are adding a U9 age division this year, so please pass this onto any U9 teams that you know of.

**We will run a Round Robin – three games guaranteed – tourney of eight teams each for ages U10-U14 and six teams for age U9.** The tournament will feature 78 games played at five different locations in Muskego, which are all within 5-10 minutes of each other: Jensen Field (JF), Mill Valley School (MVS), Lake Denoon Middle School (LDMS), Muskego High School (MHS), and Horn Field (HF). U9 will play at JF, U10 and U11 will play at MVS, U12 will play at MVS and LDMS, and U13 and U14 will play at MHS and HF. The high school diamonds are only a couple of years old, and we are fortunate to have the opportunity to use them.

The tournament will be played using the National Federation/WIAA rules with exceptions and pitching restrictions. U9 and U10 will play with 60' base lengths, U11 with 65' base lengths, U12 with 70' base lengths, and U13 and U14 with 90' base lengths. For the U12 and up, the base runners will be allowed to lead off.

Individual trophies will be awarded to the first 3 places in each division. No team trophies this year. The additional funds will be used to make the individual trophies bigger and better, so we continue with the tradition of providing some of the best in the area.

This invite will not be sent via US mail this year, unless a special request is made. Please feel free to share this invite with anyone who might be interested in our tournament. Also, if you would like for me to include someone, please provide me with their email address.
